### **Restrictions & Limitations:**

- 1) Pass is valid ONLY for the designated Monthly Pass holder (ID may be required).
- 2) GUESTS & GUEST FEES:  
Guests are restricted to using same tunnel as the Monthly Pass holder.  
Guests (accompanying the pass holder) will be assessed a \$10 "guest fee" per guest per visit.  
"Guest fee" will NOT be assessed for the catcher while using a pitching tunnel.
- 3) Monthly Pass is valid for use of ONLY 1 tunnel at any single time per visit.
- 4) Monthly Passes may not be used for Team Rentals or to pay an individual's portion of a team visit.
- 5) Use of the tunnel by the designated Monthly Pass holder is required when participating guests are present.  
*Examples of Inappropriate Use:*
  - a) Monthly Pass holder who is a non-participating individual who brings in guests to hit under the guest privilege provision of the pass
  - b) Monthly Pass holder who is a coach or other team official who brings in team members to hit under the guest privilege provision of the pass
  - c) Any situation, not described herein, that may arise that while using the Monthly Pass where the user is, in the opinion of BASES management, making a conscious effort to avoid paying appropriate tunnel rental fees
- 6) CAGE TIME:  
**January & February ONLY:** Pass use is limited to WEEKDAYS (Monday through Friday) before 6PM.  
**January through December:** Pass use is limited to 45 minutes per visit when others are waiting.  
If paying guest(s) are present, tunnel time limit will be extended by 15 minutes for each paying guest (i.e. with 2 paying guests plus Monthly Pass holder, tunnel time limited to 75 minutes when others are waiting).  
Time slots (45-minutes or greater if guests are expected) may be reserved up to 3 days in advance by telephone or in-person (e-mails reservations will not be accepted).
- 7) RESERVATIONS:  
Only 1 reserved time slot may be held by a Monthly Pass holder at any time. When making reservations, you must inform BASES of the intent to bring guest(s) in order to have the appropriate amount of cage time reserved.
- 8) A previously reserved time slot will be forfeited if the Monthly Pass holder is not present at the start of his/her reserved time (if others are waiting)... guests cannot hold a time slot for a Monthly Pass holder.
- 9) Monthly Pass may be used for lessons conducted by a non-BASES instructor at the rate of \$10 per 30-minutes. Lessons may not exceed 60 minutes in duration unless approved in advance by BASES management.
- 10) BASES reserves the right to assess a \$5 fee per "no show" for reserved time.
- 11) All Monthly Pass holders and guests will be required to have a completed BASES or Sandlot Liability Release form on-file before being allowed to use the facility.
- 12) BASES management reserves the right to make final determination on decision on immediate family member status (for reduced rates describe above). Immediate family typically includes parents, children, and/or siblings living in the same household.
- 13) BASES management reserves the right to revoke any Monthly Pass (without recourse of the holder) for failure, on the part of the Monthly Pass holder or their guests (paying or non-paying), to conduct oneself with the proper decorum.
- 14) BASES management reserves the right to revoke any Monthly Pass (without recourse of the holder) for failure to follow the Restrictions and Limitations stated herein.
